Níl an liúntas seo inchánaithe.	<b>Annual Allowance</b> This Allowance covers attendance at all meetings of the Council and committee meetings anywhere in the county. Full payment is subject to an 80% attendance requirement. This Allowance is not taxable.
<b>Íocaíocht Ionadaíochta</b> Is é seo an t-aon íocaíocht mar a bheadh tuarastal ann a thugtar do chomhairleoirí agus gearrtar cáin air sa ghnáth shlí.	<b>Representational Payment</b> This is a salary type payment and is subject to tax.
<b>Liúntas do Chathaoirligh na gCoistí Polasaí Straitéisigh</b> Íoctar an liúntas seo don ceathrar cathaoirleach ar na Coistí Polasaí Straitéisigh agus níl sé inchánaithe.	<b>Strategic Policy Committee Chair Allowance</b> This allowance is paid to the four Chairpersons of the Strategic Policy Committees and is not taxable.
<b>Costais as freastal ar chomhdhálacha, traenála etc.</b> Baineann an íocaíocht seo le costais taistil agus liúntas cothaithe do sheimineáir traenála agus comhdhálacha a cheadaigh an Chomhairle Thofa roimh ré.	<b>Expenses for attendance at conferences, training etc.</b> This payment is in respect of travelling expenses and subsistence allowance for attendance at Training Seminars and Conferences approved in advance by the elected council.
<b>Liúntas an Chathaoirleach</b> Íoctar an liúntas seo don Cathaoirleach Comhairle Chontae Chiarraí lena chostais freastail ar ócáidí sa chontae a chlúdach agus is féidir cáin a ghearradh ar chuid de.	<b>Cathaoirleach's Allowance</b> This allowance is payable to the Cathaoirleach of Kerry County Council to cover expenses for attendance at all events in the county and it is partly taxable.
<b>Liúntas an Leas-Chathaoirleach</b> Íoctar an liúntas seo don Leas-Chathaoirleach as ionadaíocht a dhéanamh don Cathaoirleach agus is féidir cáin a ghearradh ar chuid de.	<b>Leas-Chathaoirleach's Allowance</b> This allowance is payable to the Leas-Chathaoirleach to cover expenses incurred while deputising for the Cathaoirleach and it is partly taxable.

<p><b>Liúntas Fóin Póca</b> Baineann an liúntas seo le costais fóin póca a tabhaíodh agus íoctar é nuair a fhaightear sonraisc. Is é €600 uasmhéid an liúntais in aghaidh na bliana.</p>	<p><b>Mobile Phone Allowance</b> This allowance is in respect of mobile phone expenses incurred and is paid on receipt of invoices. The maximum allowance is €600 per annum.</p>
<p><b>Aisce</b> Nuair a théann comhairleoir ar scor d'fhéadfadh sé bheith i dteideal íocaíocht aisce/ex gratia ag brath ar aois , sheirbhís etc. D'fhéadfadh an íocaíocht a bheith inchánaithe ag brath ar aois agus sheirbhís chomh maith.</p>	<p><b>Gratuity</b> On retirement a councillor may be entitled to a gratuity/ex gratia payment depending on their age, service etc. The payment may be subject to tax depending on the amount, service, etc.</p>

<p><b>Liúntas do Chathaoirleach an Cheantair Bardasaigh</b> Íoctar an liúntas seo do Chathaoirligh na gCeantar Bardasach i gCill Airne, Lios Tuathail agus Ciarraí Thiar &amp; Theas.</p>	<p><b>Municipal District Cathaoirleach Allowance</b> This allowance is paid to the Cathaoirligh of Killarney, Listowel and South and West Kerry Municipal District</p>
