Níl an liúntas seo inchánaithe.	<b>Annual Allowance</b> This Allowance covers attendance at all meetings of the Council and committee meetings anywhere in the county. Full payment is subject to an 80% attendance requirement. This Allowance is not taxable.
<b>Íocaíocht Ionadaíochta</b> Is é seo an t-aon íocaíocht mar a bheadh tuarastal ann a thugtar do chomhairleoirí agus gearrtar cáin air sa ghnáth shlí.	<b>Representational Payment</b> This is a salary type payment and is subject to tax.
<b>Liúntas do Chathaoirligh na gCoistí Polasaí Straitéisigh</b> Íoctar an liúntas seo don chúigear cathaoirleach ar na Coistí Polasaí Straitéisigh agus níl sé inchánaithe.	<b>Strategic Policy Committee Chair Allowance</b> This allowance is paid to the five Chairpersons of the Strategic Policy Committees and is not taxable.
<b>Bord Forbartha an Chontae</b> Íoctar an liúntas seo do Chathaoirleach Bhord Forbartha an Chontae amháin agus tá sé inchánaithe.	<b>County Development Board</b> This allowance is payable to the Chairperson of the County Development Board and is taxable.
<b>Costais as freastal ar chomhdhálacha etc.</b> Baineann an íocaíocht seo le costais taistil, liúntas cothaithe agus táillí cláraithe do sheimineáir traenála agus comhdhálacha a cheadaigh an Chomhairle Thofa roimh ré.	<b>Expenses for attendance at conferences, etc.</b> This payment is in respect of travelling expenses, subsistence allowance and Registration Fees for attendance at Training Seminars and Conferences approved in advance by the elected council.
<b>Liúntas Fóin Póca</b> Baineann an liúntas seo le costais fóin póca a tabhaíodh agus íoctar é nuair a fhaightear sonraisc. Is é €600 uasmhéid an liúntais in aghaidh na bliana.	<b>Mobile Phone Allowance</b> This allowance is in respect of mobile phone expenses incurred and is paid on receipt of invoices. The maximum allowance is €600 per annum.

<p><b>Liúntas an Choiste Iniúcháireachta</b></p> <p>Tá an liúntas seo inchánaithe.</p>	<p><b>Audit Committee Allowance</b></p> <p>This allowance is taxable.</p>
<p><b>Liúntas an Méara</b></p> <p>Íoctar an liúntas seo don Mhéara lena chostais freastail ar ócáidí sa chontae a chlúdach agus is féidir cáin a ghearradh ar chuid de.</p>	<p><b>Mayor’s Allowance</b></p> <p>This allowance is payable to the Mayor to cover expenses for attendance at all events in the county and it is partly taxable.</p>
<p><b>Liúntas an Leas-Mhéara</b></p> <p>Íoctar an liúntas seo don Leas-Mhéara as ionadaíocht a dhéanamh don Mhéara agus is féidir cáin a ghearradh ar chuid de.</p>	<p><b>Deputy Mayor’s Allowance</b></p> <p>This allowance is payable to the Deputy Mayor to cover expenses incurred while deputising for the Mayor and it is partly taxable.</p>
