The Council proposes to introduce traffic calming measures in Cluainin Estate, Listowel.

The proposed works include a combined road narrowing and raised table pedestrian crossing with a further offset road narrowing forming a chicane.

A Public Notice was published in the Kerry Eye on Thursday, 29 September 2016 and drawings of the proposed works were put on display. The closing date for receipt of submissions and observations was Tuesday, 1 November 2016. No submissions / observations were received.
