| Ní ceadáítear colbhaí ar imeall uaigheanna. | 1 No kerbs are allowed around graves. |
| Ní mór Leaca Tuama agus Crosa a chur in airde ar an mbunchloch atá in áit. | 2 Headstones and Crosses must be erected on the foundation provided. |
| Ní ceadáítear Leaca Tuama ná Crosa atá níos airde ná 1.2 méadair (4 throigh) os cionn talún. | 3 Any headstone or cross must not exceed 1.2 meters (4 feet) in height above the adjoining ground level. |
| Ní ceadáítear ábhar meatach (adhmad nó iarann mar shampla) a úsáid in aon leacht ná struchtúr sa Reilig. Ní mór cead fé leith a fháil i scríbhinn roimh ré ón Innealtóir Seirbhísí Uisce sula n-úsáidfí ábhar plaisteach nó de dhéantús duine (tacair). | 4 Perishable materials (such as timber or iron work) are not permitted as part of any monument or structure in the Burial Ground. Special permission must be obtained in writing in advance from the Water Services Engineer for the use of plastic or man-made (synthetic) materials. |
| Ní ceadáítear cloichíní ar uaigheanna. | 5 No chippings are permitted over graves. |
| Ní mór bláth fhleascanna, bláthanna etc a bhaint faoi cheann trí mhí tar éis na sochraide agus an uaigh a chothromú agus féar a chur ag fás air. Ceadáítear bláthanna úra ag leac an tuama ach de cheart ag an gComhairle iad a bhogadh chun an féar a bhaint. Tá spás ag bunchloch leac an tuama do photaí bláthanna níos buaine. | 6 Wreaths, flowers etc. must be removed no later than three months after an interment and the grave must be levelled and grassed. Fresh flowers may be placed at headstone but the council reserved the right to remove these to facilitate grass cutting. Room is available on the headstone foundation for placement of more permanent flower containers if desired. |
| Ní mór clocha/bruscar tar éis obair thógála/chothabhála ar leac an tuama a bhaint as an reilig. | 7 Stones/debris from headstone erection work or maintenance must be removed from the burial ground. |
| Tá údarás ag Comhairle Contae Chiarraí aon fhorbairt ná bac nach luíonn leis na rialacha agus na coinníollacha thuas a bhaint. Níl aon dlíteanas ar Chomhairle Contae Chiarraí, a gcuid giollaí ná gníomhairí, ag éirí as nó de bharr aon fhorbairt ná bac neamh-údaraithe a bhaint. | 8 Kerry County Council are authorised to remove any development/obstruction which does not comply with the conditions set out above.
