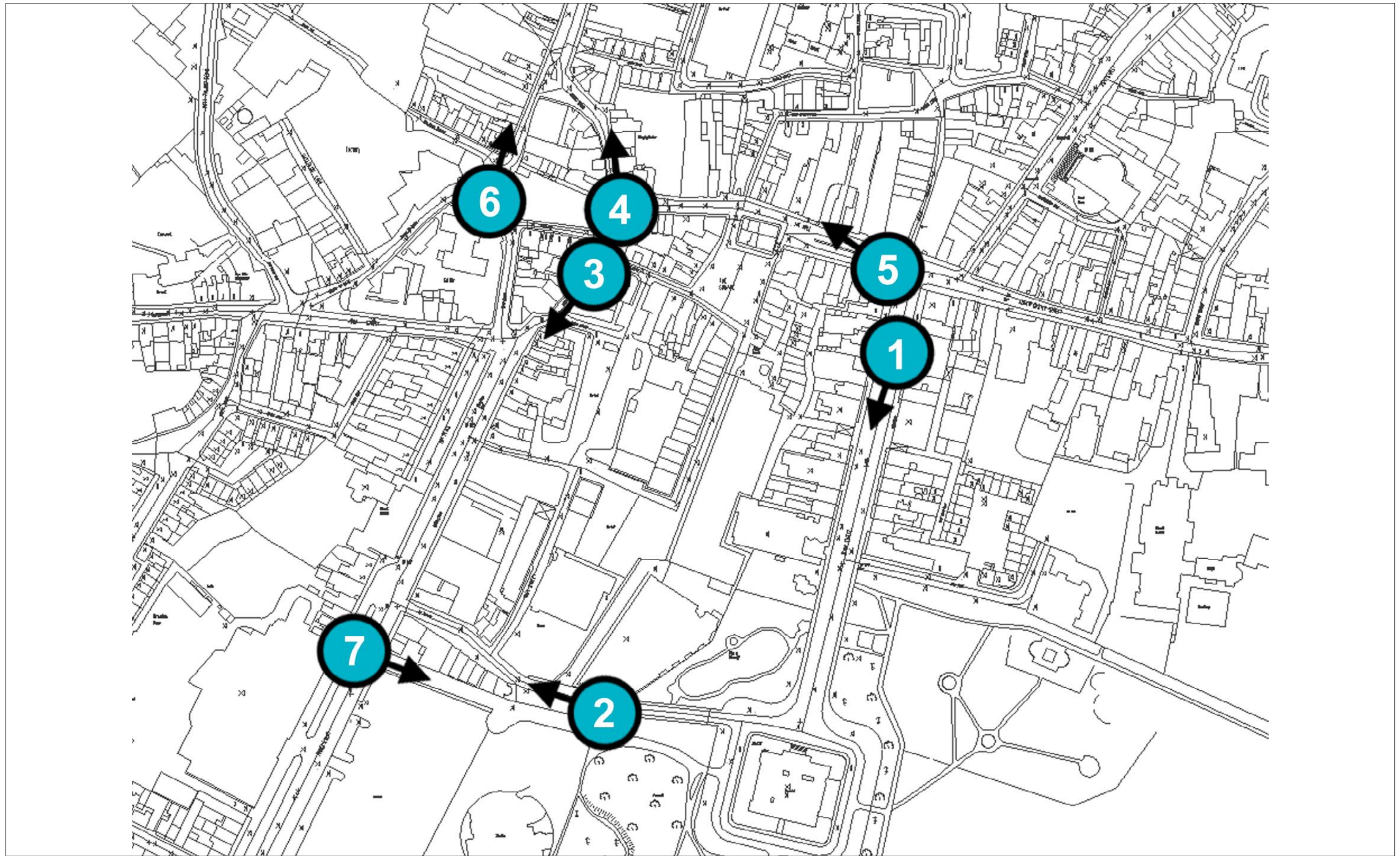


Figure: MAP **Rev: 02**
