Féadfaidh duine é/í féin a ainmniú mar iarrthóir nó féadfaidh moltóir é/í a ainmniú, lena t(h)oil i scríbhinn ach an moltóir a bheith cláraithe mar thoghthóir rialtais áitiúil i dtoghcheantar an údaráis áitiúil ina bhfuil an t-iarrthóir le h-ainmniú.

Ní mór deimhniú cleamhnaithe polaitiúil a chur le páipéar ainmniúcháin iarrthóirí ó pháirtithe polaitiúla cláraithe agus sin a chur faoi mo bhráid lena f(h)oirm ainmniúcháin chomhlánaithe.

Mura gcuirtear deimhniú faoi mo bhráid, ní mór don iarrthóir, roimh an t-am is déanaí chun ainmniúcháin a fháil-

- cúig aontú dhéag leis an ainmniúchán a fháil trí dhearbhuithe reachtúla ó thoghthóirí rialtais áitiúil cláraithe sa toghcheantar áitiúil ábhartha (tá na foirmeacha ar fáil uaimse nó ón údarás cláraithe), nó
- éarlais €100 a íoc (is féidir éarlais a íoc thar ceann an iarrthóra freisin).

Is é meán lae an 3 lá Bealtaine 2014 an t-am is déanaí le hainmniúcháin a ghlacadh.

Is féidir leis an iarrthóir nó lena m(h)oltóir páipéir ainmniúcháin chomhlánaithe a thabhairt go díreach dom i m'óifig, **ó 10am an 26 lá Aibreán 2014 go meán lae ar an lá is déanaí le hainmniúcháin a ghlacadh.**

Tá ceangal orm faoin dlí a bheith i láthair le glacadh le hainmniúcháin idir 10am agus meán lae agus idir 2pm agus 5pm an 2 lá Bealtaine 2014 agus idir 10am agus meán lae an 3 lá de Bealtaine, 2014.

NOTICE OF ELECTION KERRY COUNTY COUNCIL

An election of members for each of the local electoral areas of Killarney, South and West Kerry, Listowel and Tralee, of the above-mentioned local authority is about to be held.

Nomination papers may be obtained from the address below during the usual office hours.

A person may nominate himself/herself as a candidate or may, with his/her consent, be nominated by a proposer who is registered as a local government elector in the local electoral area of the local authority for which he/she proposes to nominate the candidate.

A nomination paper from a candidate of a registered political party must have a certificate of political affiliation attached which must be produced to me with his/her completed nomination paper.

If no certificate is attached, the candidate must, before the latest time for receiving nominations, either-

- secure 15 assents to the nomination by way of statutory declarations by local government electors registered in the relevant local electoral area (forms available from me or the registration authority), or
- make a deposit of €100 (deposit may also be made on the candidate's behalf).

The latest time for receiving nominations is 12 noon on the 3rd day of May, 2014.

Completed nomination papers may be delivered to me in person by the candidate or his/her proposer at any time when I am at my office, **from 10am on the 26th day of April, 2014 until 12 noon on the last day for receiving nominations.**

I am required by law to attend to receive nominations between 10am and 12 noon and between 2pm and 5pm on the 2nd day of May, 2014 and between 10am and 12 noon on the 3rd day of May, 2014.

If the election is contested, a poll will be taken on the 23rd day of May, 2014 between the hours of 7 am and 10 pm.
