1) (a) Confirmation of the minutes of the meeting of the following meetings:

- (1) Ordinary Meeting of the Members of the Municipal District of Listowel held on 14th September 2020.

- (1) In accordance with the Local Government Act 2001 (as amended) and having regard to Section 180 of the Planning and Development Act 2000 in relation to the taking in charge of estates, to consider any objections or representations received and the making of an Order declaring the following roads to be a public road pursuant to Section 11 (2) (i) of the Roads Act 1993: Declaration of Road to be Public Road at the following locations:
 - **Clanmaurice, Lixnaw** - Road from its junction with L-1029-6 to all terminal points within the estate Clanmaurice, Lixnaw Map 16-18 (serving 10 houses). Total Length of road to be Taken in Charge: - 110m.
 - **Knockane Gardens, Knockane, Listowel** - Road from its junction with the L-6034-0 to all terminal points within the estate Knockane Gardens, Knockane, Listowel Map 19-09 (serving 4 houses). Total Length of road to be Taken in Charge: - 156m.
- (2) To consider the Chief Executive's Report on the Public Consultation in compliance with Part XI of the Planning & Development Acts 2000-2020 as set down in Part 8 of the Planning and Development Regulation, 2001 – 2020 for: **Coastal Protection Works at Cliff Road, Ballyheigue.**
- (3) Review of the Town Centre Mobility Plans for the Listowel Municipal District.

2. Economic & Community Development Directorate

(b) Notices of Motion

1. **Cllr. M. Kennelly:** That Kerry County Council produce a defibrillator map for all defibrillators situated around Listowel Town – please include in the map details of any future installations. We need to highlight and increase public awareness on where this life-Saving Equipment is located and where it can be accessed in an emergency.
2. **Cllr. A. Thornton:** I wish the members to support my call for an urgent meeting with NBI regarding the Broadband roll out.
3. **Cllr. A. Thornton:** That the Members agree to a meeting with Fáilte Ireland regarding the Visitor Experience Programme for North Kerry as part of the Wild Atlantic Way.

Questions

1. **Cllr. A. Thornton:** Can the members agree to call on the Kerry Sports and Recreation Partnership to collaborate with Kerry County Council in relation to new sports that may be encouraged in the Listowel area?

3. Water, Environment, Fire and Library Services Directorate

- (a) **To note update report from Water, Environment, Fire and Library Services Directorate.**

(b) Notices of Motion

1. **Cllr. R. Beasley:** That Kerry County Council take whatever measures necessary to ensure the Blue Flag is returned to the North Beach, Ballybunion.
2. **Cllr. J. Moloney:** In light of funding announcements by Irish Water for "Shovel Ready" projects, how many projects are Shovel Ready in the District? Can an application be made to proceed with water infrastructure improvements? E.g. Ballyduff and Duagh.
3. **Cllr. M. Kennelly:** That Kerry County Council contact Irish Water to immediately suspend commercial billing to businesses in North Kerry that have been closed by Covid-19 and to refund businesses that have paid – these businesses have been closed since 15th March and are being charged for a service for which they are not availing.

4. **Cllr. M. Kennelly:** Can Kerry County Council request Irish Water to attend our next meeting to explain how the lack of investment in North Kerry has led to continuous water breaks in the Moyvane/Knockanure area – where 28 call-outs have been reported for this area in 2020 alone – this has led to 2 National schools losing 4 schooldays each since their return in September.
5. **Cllr. A. Thornton:** Can Kerry County Council provide me with the burst and repair history for the Lixnaw-Finuge water line over the last 3 years?

(c) Questions

1. **Cllr. R. Beasley:** What is the up to date position on Causeway Graveyard?
2. **Cllr. T. Barry:** Can Kerry County Council please revisit the issue of providing a public sewerage connection for the residents of the Dirha Cottages and surrounding area in Listowel?

4. Housing Directorate

(a) To note update report from Housing Directorate.

(b) Notices of Motion

1. **Cllr. R. Beasley:** That Kerry County Council ensure that all tenants that need replacements and repairs for stoves and ranges, windows and doors, radiators and other important appliances to a normal home including hinges, locks and catches be replaced in all homes where needed. Especially in these times of a serious Pandemic as we go into the depths of Winter and with Christmas approaching. All paying tenants are entitled to this service without further delay.
2. **Cllr. M. Kennelly:** That Kerry County Council immediately replace the stove at the home of **[Details with Directorate]** as this is the only source of heating for this Family and can Kerry County Council explain what is left in the Housing Maintenance Budget for 2020.

(c) Questions

1. **Cllr. T. Barry:** Has all of this year's Housing Maintenance budget for the Listowel Municipal District Area been spent?
2. **Cllr. J. Moloney:** Can roof insulation be provided for **[Details with Directorate]**?

5. Roads, Transportation & Marine Directorate

(a) To note update report from Roads, Transportation & Marine Directorate.

(b) Notices of Motion

1. **Cllr. R. Beasley:** That Kerry County Council investigate the condition of the cliff overlooking Ladies Beach, Ballybunion, which has deteriorated considerably over the past eight years. The cracks on the wall overhead have become much more visible along with lags on the path on Cliff Road.
2. **Cllr. R. Beasley:** That Kerry County Council repair and replace the railings around the Cliff Walk, Ballybunion which have broken and rotted in many places over the years. This is a Health and Safety issue.
3. **Cllr. R. Beasley:** That Kerry County Council carry out major repairs on many of the Secondary and Tertiary Roads in the Listowel Municipal District Area, which are in a disgraceful condition.
4. **Cllr. T. Barry:** That Kerry County Council will carry out repairs to the L6031 road at Clounphorus, Moyvane.
5. **Cllr. T. Barry:** That Kerry County Council will carry out repairs to the L6024 road in Moyvane.
6. **Cllr. T. Barry:** That Kerry County Council could provide a streetlight at the section of road between Stoker's Drive and Cluainin Estate in Listowel?
7. **Cllr. T. Barry:** That Kerry County Council will address the ongoing flooding issue that is affecting the following homeowners; **[Details with Directorate]**.
8. **Cllr. T. Barry:** That Kerry County Council. carry out repairs to the road surface at Leitrim East, Moyvane, the L6023.
9. **Cllr. M. Foley:** That Kerry County Council would remove the noxious weeds (knotweed and horse tail) growing on their property at the back of **[Details with Directorate]** and which is encroaching on a neighbouring property.
10. **Cllr. M. Foley:** That Kerry County Council would provide traffic calming measures in Marconi Estate, Ballybunion.
11. **Cllr. M. Foley:** That Kerry County Council would construct a footpath at Doon Road, Ballybunion from V31 X642 to Doon Church and also introduce some type of traffic calming measures in the area.

12. **Cllr. M. Foley:** That Kerry County Council would take immediate action to prevent damage to the L6010-23 near Carrigafoyle Castle as the road is being undermined by coastal erosion.
13. **Cllr. M. Foley:** That Kerry County Council would repair the area between the footpath and road which carries drainage water at Quay Street, Ballylongford (L1010-0).
14. **Cllr. M. Foley:** That Kerry County Council would erect signs on the road from Rusheen to Carrig Island in Ballylongford alerting motorists of pedestrians out exercising on the road.
15. **Cllr. J. Moloney:** What is the current timeline for the repair of potholes on (a) Regional and (b) Local Routes?
16. **Cllr. J. Moloney:** Can the Council urgently repair the L10038 in Leanamore?
17. **Cllr. J. Moloney:** That the Council immediately remove all the bollards restricting parking in Listowel.
18. **Cllr. J. Moloney:** Can the Council begin formulating ideas and structures to facilitate outdoor seating for businesses for next year?
19. **Cllr. J. Moloney:** Can the Council again make enquiries about linking the footpath in Bedford, Listowel by Sli na Spéire?
20. **Cllr. M. Kennelly:** That Kerry County Council immediately prioritise the completion of the public footpath with lighting at Upper Clieveragh, Listowel – this area (which is within the 50 KM speed limits) is currently very dangerous for ALL road users.
21. **Cllr. M. Kennelly:** That Kerry County Council carry out Health & Safety roadworks in the Islandganniv Estate, Greenville, Listowel as in its current state, it has become highly dangerous for the residents.
22. **Cllr. A. Thornton:** That Kerry County Council review the speed limit change at Ballynageragh, Lixnaw, which causes an increase in speed on a dangerous bend.

1. **Cllr. R. Beasley:** How soon can we expect to see the water lodging at Killheanna Church yard, Ballybunion drained away?
2. **Cllr. R. Beasley:** How soon can we see Cinema Lane Ballybunion being surfaced at the Church Road End?

3. **Cllr. M. Foley:** That Kerry County Council could carry out urgent repairs on the L10029-0, Ballyline, Ballylongford.
4. **Cllr. M. Foley:** That Kerry County Council could carry out urgent repairs on the L1004-38, Larha, Asdee.
5. **Cllr. M. Foley:** That Kerry County Council could carry out urgent repairs on the L10028 Ahanagan Lower, Ballylongford.
6. **Cllr. M. Foley:** That Kerry County Council could carry out urgent repairs on the L10027 Ballymacasy, Ballylongford.
7. **Cllr. J. Moloney:** What is the status of the tree management plan for Childers Park and Woodlands?
