Declaration of Roads to be Public Roads**

Acht na mBóithre 1993/Roads Act, 1993

In accordance with Section 180 of the Planning and Development Act, 2000 (as amended), Kerry County Council hereby gives notice of its intention to consider the making of an order under Section 11 of the Roads Act, 1993, to declare the roads set out in the schedule hereunder to be public roads.
