

## Relevant Bodies

Section 5(5)(n) of the Regulation of Lobbying Act 2015 refers to relevant “communications between members of a relevant body appointed by a Minister of the Government, or by a public service body, for the purpose of reviewing, assessing or analysing any issue of public policy with a view to reporting to the Minister of the Government or public service body on it.”

A ‘relevant body’ is defined as a body: *the members of which are appointed by a Minister of the Government or by a public service body and include one or more persons who are designated public officials and one or more persons who are neither public servants nor engaged for the purposes of a public service body, and which conducts its activities in accordance with the Transparency Code.*
