

Local Development Strategy (LDS) Overview

LEADER LDS – Community Led Local Development

•Open and Inclusive Consultation Process

•EU Charter of Fundamental Rights

 Emphasis on supporting areas and communities not previously benefited from LEADER to-date

Local Development Strategy (LDS) key features:

- In the context of the LEADER element of the CAP Strategic Plan (CSP), LDS = Plan designed by members of rural communities - through their LAGs, to support sustainable development of their own rural communities.
- LAG = Local Action Group. Coordinates selection of projects and works with local experts Implementation Partners – and project promoters
- LDSs designed through a "bottom-up" process. Any member of the rural community can participate. Takes full and comprehensive_consideration of not just local needs but also local potential.
- LDS examines the strengths, weaknesses, opportunities and threats (SWOT) of a particular area and outline types of actions to be supported. Address weaknesses & threats. Exploit strengths & opportunities.
- LDS should be **realistic reflection** of how LEADER funding might best be used for sustainable development.
- LDS fully consider on-going or planned actions of other agencies supporting their area.
- LDS should be complementary to and support EU, national, regional and local strategic plans (e.g. Local Economic and Community Plans (LECPs).

- I gcomhthéacs ghné LEADER den Phlean Straitéiseach CBT (CSP), is plean í an straitéis forbartha áitiúil (LDS) atá deartha ag baill de phobail tuaithe, trína LAGanna, chun tacú le forbairt inbhuanaithe a bpobal tuaithe féin.
- Tá LDSs deartha trí phróiseas "ón mbun aníos" a éascaíonn rannpháirtíocht aon bhall den phobal tuaithe agus breithniú iomlán cuimsitheach a dhéanamh ní hamháin ar riachtanais áitiúla ach ar acmhainneacht áitiúil freisin
- Ba cheart do LDS scrúdú a dhéanamh ar na láidreachtaí, na laigí, na deiseanna agus na bagairtí (SWOT) a bhfuil réimse ar leith os a gcomhair agus na cineálacha gníomhaíochtaí a dtabharfar tacaíocht dóibh chun aghaidh a thabhairt ar na laigí agus na bagairtí a leagan amach agus leas a bhaint as na láidreachtaí agus na deiseanna a aithníodh.
- Ba cheart go mbeadh an LDS ina léiriú réadúil ar an gcaoi is fearr a bhféadfaí maoiniú LEADER a úsáid chun tacú le forbairt inbhuanaithe an cheantair atá leagtha amach.
- Ba cheart dó breithniú iomlán a dhéanamh freisin ar gach gníomh atá ar siúl nó atá beartaithe ag gníomhaireachtaí eile a bhfuil sé de chúram orthu tacú le forbairt ina gceantar nó a bhfuil baint acu leis an bhforbairt sin. Go háirithe, ba cheart don LDS a bheith comhlántach agus tacúil le pleananna straitéiseacha AE, pleannana náisiúnta, réigiúnacha agus áitiúla amhail na Pleananna Áitiúla Eacnamaíocha agus Pobail (LECPanna)

- Must contribute to the CSP, in particular specific objective set out in Article 6(1)(h) EU Regulation 2021/2115
 - 'to promote employment, growth, gender equality, social inclusion and local development in rural areas, including bio-economy and sustainable forestry.'
- Vison for LEADER has been set out in the CSP, developed in consultation with all stakeholders and views of the Commission also taken into account when finalising
 - Support for rural enterprises and communities
 - Maximise opportunities presented by the green economy
 - Embrace the diversity of rural communities by involving all members of society in the development process

What EU Commission is telling us this time:

Observations from the EU Commission on Ireland's LEADER intervention contd.

- How partnership principle will be put into practice, 'have young people, women, less advantaged groups etc. participating in the partnership and in the decision-making'.
