ALT 75 d'ACHT NA mBÓITHRE 1993 SECTION 75 OF ROADS ACT 1993

Notice is hereby given that, pursuant to Section 75 of the Roads Act 1993, and the Temporary Closing of Roads Regulations 1994, Kerry County Council **is proposing** to close to public traffic the following road:

Road Closed: L-1002 Ballyeagh, Ballybunion, from the junction with the R-551 at Barrack Cross to the junction with the L-6026 at Ballybunion Golf Club.

Road Closing Times: From 8.00 a.m. on Monday, 29^{th} January to 6.00 p.m. on Wednesday, 31^{st} January 2024 (24 hour daily closure)

The purpose of the road closure is to facilitate the connection of a new development to the existing watermain.

Diversions will be as follows:

Traffic travelling from Ballyduff to Ballyeagh/ Ballybunion Golf Club	Continue along the R551 towards Ballybunion Town to Ahafona Junction, turn left onto the R-551, continue along the R-551 East End, to the junction with the L-6202, turn left on to L-6202 Kit Ahern Road, continue along the Kit Ahern Road to the junction with the L-1002 Sandhill Road, take a left onto Sandhill road. Continue along the Sandhill Road to Ballyeagh.
Traffic from Ballyeagh/ Ballybunion Golf Club travelling to Ballyduff	Continue along the L-1002 towards Ballybunion Town, at the junction with the L-6202 turn right on to Kit Ahern Road, continue along Kit Ahern Road to the junction with the R-551, turn right on to the R-551 East End, Ballybunion, continue along the R-551 to Ahafona Junction, at Ahafona Junction take a right onto the R-551 Ballyduff Road.

Diversions will be clearly signposted. Local Access will be provided for Emergency Services and local residents.

Any person having an objection to the above proposal should lodge same, in writing, marked **Road Closure**, with the Administrative Officer, Roads and Transportation Department, County Buildings, Tralee, County Kerry or by e-mail to roads@kerrycoco.ie not later than **4.00 p.m. on Monday**, 8th **January 2024.**
