#### (b) Notice of Motion

- **1. Cllr. N. Moriarty:** That Kerry County Council examine all avenues to secure consistent broadband coverage for Beaufort Village.
- **2. Cllr. N. Moriarty:** That an appropriate commemorative plaque be erected in conjunction with the local community and International Dark Sky Reserve committee to recognise the tenth anniversary of the official establishment of the status, and to recognise the efforts of those who made it possible.

Moriarty:** That we assist in all ways possible the efforts of the local community involved with Westcove Pier, to ensure that a FLAG application will go ahead this year to secure the public pier there and upgrade the existing facilities. A lease is being progressed between a willing neighbouring landowner and the Council and I would ask that this be prioritised for completion to allow for said funding application.
- **2. CIIr. N. Moriarty:** That we ensure that all MAC's and designs etc. be carried out for Reenard Slipway in preparation for a funding stream to open up for the extension works that are necessary there. This is a crucial project both from a Tourism and overall economic development perspective. In preparation for the Greenway and the potential of UNESCO, a second corridor accessing Valentia Island is essential.

Cahill:** That Kerry County Council initiate a major Coastal Protection Scheme at Rossbeigh that will include rock armour and marram grass and examine the possibility of utilising used natural Christmas Trees to rebuild the Sand Dunes similar to the successful system used near Blackpool in Lancashire, England. Such a system not only helps rebuild sand dunes, but also makes environmentally friendly second use of unwanted Christmas Trees. Sand dunes are a natural defence against sea storm erosion and support wildlife.

Cahill:** That Kerry County Council request the Ministers for Justice and the Minister for Education to formulate and pass legislation requiring social media companies allow only those verified to be over the age of 18 years to participate on their platforms where discussions and publications of an adult nature are being shared.
- **2. Cllr. J. F. Flynn:** That Kerry County Council write to Bus Eireann and the Minister of Transport to change the rules that currently prohibit a bus driver from driving after the age of 70, despite being medically certified to do so. We are currently experiencing a shortfall of drivers.
- 3. CIIr. M. Cahill: That Kerry County Council provides the detailed numerical and financial amounts paid out to claimants in Killorglin, Caherciveen and Kenmare towns in the past 5 years due to injury suffered there through falls on damaged pavements and footpaths and in each of the villages.

  I have had reports of numerous incidences that have not been officially reported, which leads me to believe that costs involved in successful claims on Kerry County Council, far outweigh what it would cost to upgrade our footpath network.
- **4. Cllr. J. F. Flynn:** That this Council write to Minister Heather Humphries requesting her to consider a grant of €1000 for all applicants of the Local Improvement Scheme to enable them to purchase cold tar so they could temporarily improve the potholes on their roads. Many of these roads won't be resurfaced for many years and this temporary grant would mean a lot in keeping their roads drivable.

- **5. CIIr. P. Connor-Scarteen:** That, we, the Members of the Kenmare Municipal District call for and make a submission to the Minister for Agriculture, Food and Marine to ban the destructive practice of Pair Trawling by 15m wide boats within 6 nautical miles of the coast.
- **6. CIIr. J. Healy-Rae:** That we as a Council would write to the Department of Housing regarding the new rule of having to have 25 houses before you can apply for a group scheme or an extension of a group scheme.
