**ALT 75 d'ACHT NA mBÓITHRE 1993
SECTION 75 OF ROADS ACT 1993**

Notice is hereby given that, pursuant to Section 75 of the Roads Act 1993, and the Temporary Closing of Roads Regulations 1994, Kerry County Council **is proposing** to close to public traffic the following road / street:

Road Closed: L-8120 Baile an Mhathamhnaigh road from its junction with the N-86 to its junction with the L-8036.

Road Closing Times: from 07:00 am on 18th of May to 7:00 pm on 22nd of May 2026.

Reason: The purpose of this road closure is to facilitate the surfacing of the L-8120 Baile an Mhathamhnaigh Road

Diversions will be as follows:

Traffic travelling to Baile an Mhathamhnaigh, Fearann an Ístínigh & An Ghairfeanaigh	Traffic will proceed west along the N-86 from Baile an Mhathamhnaigh Cross for approx. 3.5km. Traffic will take the 2nd exit off the roundabout at the West Kerry Community Hospital and proceed north east along Bóthar na bPiarsach for 300m. Traffic will take the next right and proceed along the L-8036 for 2.5km to get to the junction with L-8120.
Traffic travelling from Baile an Mhathamhnaigh, Fearann an Ístínigh & An Ghairfeanaigh	Traffic will proceed south west along the L-8036 for 2.5km to its junction with Bóthar na bPiarsach road. Traffic will turn left onto the Bóthar na bPiarsach road and proceed southwest for 300m. Take the first exit at the roundabout at the West Kerry Community Hospital and proceed along the N-86 for 3.5km. Proceed along the N-86 for Lispole, Annascaul & Tralee.

Diversions will be clearly signposted. Local Access will be provided for Emergency Services and local residents.

Any person having an objection to the above proposal should lodge same, in writing, marked **Road Closure**, with the Administrative Officer, Roads Maintenance & Operational Services, County Buildings, Tralee, County Kerry or by e-mail to roads@kerrycoco.ie not later than **4.00 p.m. on Monday 27th April 2026**.

An Bóthar atá le Dúnadh: An L-8120 Baile an Mhathamhnaigh óna acomhal leis an N-86 chuig a acomhal leis an L-8036

Amanna Dúnta Bóthair: ón 07:00am an 18 Bealtaine go 7:00pm an 22 Bealtaine 2026.

Cúis: Is é is cuspóir don dúnadh bóthair seo ná dromchlú an L-8120 Baile an Mhathamhnaigh a éascú.

Is mar seo a leanas a bheidh malairtí slí:

Trácht ag dul go Baile an Mhathamhnaigh, Fearann an Ístínigh & an Ghairfeanaigh	Rachaidh an trácht siar feadh an N-86 ó Chros Bhaile an Mhathamhnaigh go ceann 3.5km nó mar sin. Glacfaidh an trácht an dara bealach amach ón timpeallán ag Ospidéal Pobail Chiarraí Thiar agus leanfaidh sé ar aghaidh soir ó thuaidh feadh Bhóthar na bPiarsach go ceann 300m. Glacfaidh an trácht an chéad chasadh eile ar dheis agus leanfaidh sé feadh an L-8036 go ceann 2.5km chun teacht chomh fada leis an acomhal leis an L-8120.
Trácht ag teacht as Baile an Mhathamhnaigh, Fearann an Ístínigh & an Ghairfeanaigh	Rachaidh an trácht siar ó dheas feadh an L-8036 go ceann 2.5km chuig a acomhal le Bóthar na bPiarsach. Casfaidh an trácht ar chlé ar Bhóthar na bPiarsach agus leanfaidh sé ar aghaidh siar ó dheas go ceann 300m. Glacfaidh an trácht an chéad bhealach amach ón timpeallán ag Ospidéal Pobail Chiarraí Thiar agus leanfaidh sé ar aghaidh feadh an N-86 go ceann 3.5km. Leanfaidh sé ar an N-86 chun Lios Póil, Abhainn an Scáil & Trá Lí a bhaint amach.

Cuirfear gach malairt slí in iúl le comharthaí soiléire. Cuirfear rochtain áitiúil ar fáil do na Seirbhísí Éigeandála agus do chónaitheoirí áitiúla.
